CHS Athletic Booster Dirt Lot Parking Contract

I understand and agree that student parking at the CHS Athletic Booster Lot is a privilege, and to violate any portion of this contract, or any school rule(s) can result in suspension or revocation of my parking privilege for not less than one (1) week nor more than one school year with no refund given.

I understand that this permit is for the Booster Lot Only. Not the "Senior" Lot.

I understand that if my decal is not in the correct location (lower left corner of the drivers side front windshield) or if I am parked on the school lot without prior approval from the school, I will be responsible for all towing expenses incurred and could face other consequences related to my irresponsible act.

I understand that the parking permit fee for each semester will not be refunded unless a "senior" or "handicapped" permit is issued.

I understand that I park my vehicle on CHS Athletic Booster Lot at my own and the vehicle owner's risk and that I cross the street at my own risk. Furthermore, I understand that CHS Athletic Association will not be held responsible for any thefts or damages done to my vehicle through acts of vandalism, pranks, or accidents associated with this parking lot.

I understand that any irresponsible act (i.e. off-roading, littering, blocking another car, "spinning tires") will not be permitted and will cause me to lose my permit with no refund given.

I understand that I must comply with all State of Georgia traffic and safety laws. The laws of the City of Roswell will have jurisdiction.

All vehicles using the parking lot are subject to the same search and seizure rules applicable to the school parking lot.

I understand that if I am caught using or possessing alcoholic beverages or illegal drugs on school property or in the Booster Parking Lot, I will have my parking privileges revoked at once with no refund given.

I understand that I must maintain regular and on-time attendance at CHS.

I understand that if I change vehicles I will inform the Booster Club.

I understand that if I am caught leaving campus without permission that my parking permit is subject to revocation without a refund.

I understand that a \$25 fee will be assessed for lost stickers.

I understand that if I drive another vehicle to school for any reason, your parking sticker must be on that vehicle or your car will be subject to towing.

I understand that I will park in an organized manner, and will not park on the outside of the fence; failure to follow these instructions will cause my vehicle to be towed and my permit to be revoked without a refund.
